



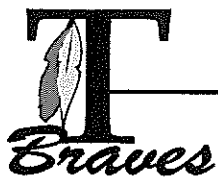

- Motion by Fundell, 2<sup>nd</sup> by Lambert to approve the Consent Agenda items. *6 Ayes, Motion Carried.*


#### II. New Business
